

**NARRATIVE**

On 08/06/2015 at about 1759 hours (all times approximate) I was dispatched by police radio to a two car non-blocking/non-injury collision near the intersection of SR 92 and Lake Drive in the city of Lake Stevens.

Arriving on scene I spoke with both drivers involved. No injuries were claimed at the time of the collision.

Based on evidence and statements by the drivers, it is found U1 and U2 were both traveling eastbound on SR 92 between SR 9 and Lake Drive. The driver of U2 stated the vehicle traveling in front of him had to brake suddenly for ducks in the roadway on SR 92, so he (U2) also had to brake to avoid colliding with the vehicle in front of him. The driver of U1 stated she observed the braking vehicles in front of her (because of the ducks in the road) and was unable to stop before hitting the vehicle (U2) in front of her.

Both driver's completed written statements and I took digital images of the vehicle damage and of the roadway.

Both driver's were given the exchange of information, along with my business card, and I cleared the scene.


