Unit 1 was stopped at the stop sign at Frontier Circle East and pulled out to go south on Frontier Circle to 91st Ave NE. Driver of Unit 1 checked both direction before pulling out and saw no vehicles until she was half cross the northbound lane of Frontier Circle. Unit 2 then struck Unit 1 at the drivers side rear passenger door. Unit 2 then fled the scene. A surveillance video was obtained from the residence at 908 Frontier Circle. In reviewing the surveillance video it shows Unit 1 pulled out and was travelling in the northbound lane causing the collision.
