



The Ford abruptly changed lanes in an effort to pass a slow forward vehicle, forcing Veh #1 onto the sidewalk of 20th St SE. Veh #1 traveled on the sidewalk approximately 40 feet and then impacted a fire water pole. This caused damaged to the front of Veh #1.

The Ford continued east onto 20th St SE and did not stop to assist.

The witness was contacted and verified what had occurred in the collision. The witness provided a description of a Ford F-250 truck with a partial license plate of #C16. The truck had a color matching canopy.

I conducted a law enforcement check of vehicles in the area and was unable to locate the vehicle.


