On December 30th, 2015 at 2026, I was dispatched to a hit and run that had just occurred at 9612 24th PI NE, Lake Stevens. I arrived at 2031 hours and contacted the reporting party, Derek Baker.

Baker said his truck, a 1988 Chevrolet Pickup (WA B07179X) was struck by a vehicle and the other vehicle drove off eastbound on 24th PI NE and then turned left, traveling northbound on Lake Dr NE. I observed the truck was parked on the south side of the street facing east. The truck had damage to the rear driver's side area, including a damaged tire. There were pieces of another vehicle on the street where the truck was hit. The pieces were gold in color, indicating the hit and run suspect was driving a gold vehicle. One of the pieces had a Saturn brand symbol on it with a part number of 2110598. I took photos of the damage and the vehicle parts that were on the ground. I asked Baker if anyone on the street had a gold Saturn and he stated the "Posey's" did. He pointed to where the Posey's house was at 9529 24th PI NE.

I went to 9529 24th PI NE and contacted Todd Posey. Todd stated he owned a gold Saturn SC bearing WA license plate #AUD0819. Todd said his son, Kyle Posey had just left the house within the last half hour in the Saturn. Todd said Kyle had a few beers before he left and said Kyle is a Heroin user. Todd stated the only reason he had the Saturn, was because Kyle crashed his other car.

I then contacted Meghan Posey at the same address. Meghan is the sister of Kyle. Meghan stated Kyle had just left the house in the Saturn within the last half hour. She said shortly after he left the house, she heard a loud crash outside. Meghan stated she went outside, but did not see anything. It should be noted, that the collision occurred down the road from the Posey household, and could not be seen from the house.

I attempted to locate Kyle Posey and the vehicle he was driving but was unsuccessful. I completed a criminal citation for hit and run and requested it be mailed to Kyle C Posey (06-03-1991) at his address.
