



NARRATIVE

On 07/11/2013 at about 1831 hours (all times approximate) I was radio dispatched to a cold hit and run collision, with possible suspect information, in the parking lot of Albertsons located at 303 91st Ave NE in the city of Lake Stevens.

Arriving on scene I spoke with the driver who had parked U2 (Nguyen) in the parking lot. Nguyen stated he had been contacted at his place of employment by witness Quatrine. Witness Quatrine supplied a vehicle license plate number of #298YMJ and a digital image of the plate to Nguyen, informing Nguyen this vehicle (U1) had struck his vehicle (U2) and then left the scene without leaving any contact information. The digital image of U1 appeared to be a gold in color Lincoln SUV. I ran the suspect vehicle license plate for U1 and found it to be registered to a gold in color 2002 Lincoln navigator to a Clayton and Karen Meinhold at the address of 1011 79th Ave SE in the city of Lake Stevens.

I obtained Nguyen's written statement and took several digital images of his damaged vehicle. Based on the damage to Nguyen's vehicle (U2) it is found that U1 was attempting to park on the driver's side of U2 when U1 struck the driver's side door mirror and front driver's quarter panel of U1; causing obvious damage.

I called witness Quatrine who informed me he had witnessed U1 cause damage to U2 and that the female driver had gotten out of U1, looked at the damage to both vehicles, rubbed the damage on U2 and then returned to her vehicle where she appeared to be writing on something. The female driver of U1 was described as being "mid aged" and having blond hair. Quatrine stated the female driver of U1 then went into the store and failed to leave any contact information when she returned and left the parking lot.

I then went to the address in Lake Stevens for U1. The female registered owner of U1 was found to be Karen P. Meinhold DOB 1963 having blond hair. I also observed U1 parked in the driveway and observed what appeared to be recent damage to the front passenger corner of the vehicle which is consistent with striking U2.

Meinhold stated she was aware she had struck U2 and claimed to have waited for 15-20 minutes for the owner of U2 to arrive. After waiting, and no owner showing up, Meinhold claimed to have left her business card on the driver's door window of U2; said to be placed in the window seal.

Meinhold supplied her driver's license, vehicle registration and current proof of vehicle insurance. I gathered Meinhold's information and began a collision report. Meinhold also completed a written statement about the incident. I took several digital images of U1.

I returned to Nguyen and provided him with Meinhold's information for U1.

I later made a CD-R of the digital images of both U1 and U2 that I had taken with my digital camera. The CD-R was then logged as evidence and secured in an evidence drop bin at the Lake Stevens Police Department.

At this time there are no criminal charges or traffic related infractions being issued in this incident. I also stopped by witness Quatrine's address and provided him a witness statement; which he said he would complete and drop off at the Police Department.




