



NARRATIVE

On 03/07/2015 at about 1656 hours (all times approximate) I was dispatched by police radio to a single vehicle collision in the 10800 block of 29th Street NE in the city of Lake Stevens. The single vehicle had been described to 911 as a green in color Honda displaying license plate #361YWG. At about 1705 hours Sgt. Brooks went out with the vehicle involved in the collision in the 11200 block of 30th Street NE. A short time later I arrived on scene with Sgt. Brooks. At this time a teen male on scene claimed he had been the driver of the vehicle at the time of the collision. I noted damage to the front passenger quarter area and the front passenger tire of the vehicle which had disabled the vehicle's movement at this location. In the back seat of the vehicle there were parts of the vehicle the driver claimed had been put in the vehicle after the collision.


The male teen driver was identified by a Washington State instruction permit to be Christian Trunell DOB 1998. Trunell claimed the vehicle belongs to a friend (16 year old Patton) and that he had permission to drive the vehicle from Patton and Patton knew he (Trunell) did not have a driver's license. Trunell stated Patton also does not have a driver's license. The vehicle was found to be registered to Sharon Weston out of Redmond; later found to reside in the 10800 block of 29th Street NE (where the collision had occurred).

Based on evidence and statements by Trunell, it is found that Trunell had been operating U1 eastbound from Patton's residence in the 10800 block of 29th Street NE. Trunell claimed he was going to the Lake Stevens High School (two blocks away from the collision scene) to pick up some friends. Trunell claimed he observed a ball roll into the street and a small child chasing the ball as he traveled on 29th Street. Trunell claimed the small child appeared to not see the approaching/passing vehicle. Trunell claimed he heard a "thud" and believed he may had struck the child and/or ball. Trunell continued to drive forward, after the thud, and was looking behind him to see if he had struck the child and/or ball when U1 changed course (to the right), drifting out of the eastbound lane of travel and struck the rock retaining wall; causing reportable damage to U1 and the retaining wall. Trunell claimed he had stopped at the scene of the collision and that a neighbor began yelling at him which scared him. Trunell stated he continued to drive the vehicle, away from the collision scene, to where U1 could not be moved any further (11200 30th Street); partially blocking the eastbound lane of travel.

Trunell claimed 16 year old James Guilliam had been in the vehicle with him at the time of the collision and had left the scene prior to police arriving.

Trunell completed a written statement about the collision. Trunell was cited for operating a motor vehicle without a valid operator's license. Trunell's guardians (Grandparents) came to the scene and spoke with police about the incident.

Patton and her parent were contacted about the collision. The vehicle was removed from the scene by Rescue Towing at the owner's request.




