



**NARRATIVE**

On 11/17/15 at a call time of about 1711 hours (all times approximate), I responded to a collision at SR204 and 81st Ave SE, in the city of Lake Stevens.

Vehicle 1 (LIC: ATL8684) was traveling westbound in the 8100 block of SR204 when a severe cross wind blew over a tree, which landed on the vehicle.

Vehicle 1's driver was uninjured and privately towed his vehicle from the scene.

I took digital photographs of the damaged vehicle, which were later printed and added to the case report and copied to a compact disk and booked into evidence as item #15-201317/1.
