On 12/04/2015 at approximately 1818, I was working as a general commissioned uniformed police officer for the City of Lake Stevens police department driving a marked police vehicle equipped with emergency lights and siren.

I was dispatched to a multiple vehicle crash in the 1700 block NE of SR 9 involving five (5) or six (6) vehicles blocking SR 9.

While I was enroute Dispatch advised the causing vehicle, later positively identified as WA license AUD8741 being driven by Taylor W Caveness 07/03/1996, had fled the scene. The vehicle was reported as fleeing at a high rate of speed east on Lundeen Parkway.

As I arrived on scene Dispatch advised the suspect vehicle was being reported at Norm's market, located at 10020 Lundeen Parkway. Norm's Market is approximately .8 of a mile from the collision location. It should be noted there are numerous locations CAVENESS could have safely pulled over and reported his involvement in the collision but didn't.

I noted there were five (5) vehicles involved that had pulled to the northbound east (right) turn lane. There is insufficient shoulder to safely move the vehicles off the roadway.

As I began processing the collision scene multiple Fire/Aid units arrived on scene and began providing patient care to the drivers and passengers effectively shutting down two lanes of SR 9 during 'rush hour'.

LSPD Sgt. Miner responded to Norm's Market in an effort to contact the suspect vehicle - CAVENESS.

I was told the crash was one of a domino effect i.e. CAVENESS crashed into a Mini Cooper which crashed into a Toyota Camry which crashed into a stopped Hyundai which crashed into a stopped Chrysler Concorde which crashed into a stopped Jeep.

The Mini cooper was being driven by Laura Molleker who told me her back and neck hurt but declined Aid.

The Toyota was being driven by Sarah Crist who told me she was starting to stiffen but didn't need to go to the hospital.

The Hyundai was being driven by Laura Ramos and had Albert Ramos as a passenger. No injuries were reported by either.

The Chrysler was being driven by Heather Cromwell and had her three children as passengers: Brett Desjardins, Isabella Hensley and Lilian Hensley. No injuries were reported.

The Jeep was being driven by Kellie Weed and had her four children as passengers: Wyatt Weed (11), Ryder Weed (2 months), Arlie Weed (7) and Jordan Weed (9). No injuries were reported.

The five driver's stories were similar: They were either stopped or slowing to a stop for the red light/signal at the intersection of Lundeen Parkway/SR 9 when they were struck from behind. I was very specific in my questioning on whether there was one or two impacts from behind.

MOLLEKER (Mini Cooper) told me she heard tires sliding then she was struck from behind.

CRIST (Toyota) reported she heard tires sliding, heard an impact of a car crash and then she felt her vehicle get hit.

While I was completing my investigation of the collision and gathering information Dispatch advised the girlfriend, Alexis Brocker, of the suspect (CAVENESS) had called to report he was asking her to come pick him up at Jay's Market. Jay's Market is located in the 1900 block of Main St, which is approximately 2.4 miles away from the collision scene. Additionally, Dispatch advised BROCKER advised that when she told him to call the police he told her not to.

Sgt. Miner handled the phone calls to BROCKER and was able to convince CAVENESS to return to Norm's Market to meet with him.

For further and/or specific information regarding that reference Sgt. Miner's case narrative.

All involved drivers' were provided with witnesses statements and asked to fill them out. I facilitated the transfer of vehicles, drivers and Insurance information. Once their questions were answered they were released.

While I was processing the various documents an adult male and female, later positively identified as Edmund and Breana Pasowicz, approached me and told me they had followed the hit and run vehicle to Norm's and had called 911 with that information. Edmund continued by telling me he had seen the crash, saw the vehicle flee, followed the vehicle and tried to detain the male driver (CAVENESS).

Edmund told me when he reached into the vehicle to stop CAVENESS he began driving away with Edmund in the window. Edmund said he drew his personal concealed carry firearm and ordered the male to stay where he was. Edmund told me the male screamed something like 'No' and drove away.

All involved drivers asked if they could complete their statements at home and turn them in at a later date. I agreed.

Mrs. Weed's vehicle wouldn't start due to the collision. She requested Rescue Towing be summoned to the scene so her vehicle could be towed to her residence. Once the Tow truck had arrived and safely removed the vehicle I went to Norm's Market where Sgt. Miner had CAVENESS detained.

I met with Sgt. Miner who told me CAVENESS had told him that he had crashed into some cars on SR 9 and got scared. He took off because of his fear. Sgt. Miner handed me a completed statement form. He told me CAVENESS had written it while they waited for my arrival. I read the statement and noted CAVENESS had written that the vehicle that had been in front of him wasn't paying attention and had caused a crash. He swerved to avoid the Mini Cooper but wasn't able to. In his statement he wrote that he drove around the corner to get off the highway and parked at Norm's Market (almost a mile away) to call his girlfriend.

Sgt. Miner confirmed CAVENESS' excited verbal statement differed from the written one provided while they waited.

I contacted CAVENESS and told him he had one (1) chance and one (1) chance only to come clean and tell me the truth about what happened.

CAVENESS stammered and then began telling me the Mini Cooper caused the crash because she wasn't paying attention and that he tried to avoid crashing into her but couldn't.

I stopped him and told him he was lying. I told him I could understand he had gotten scared but not the fleeing a scene. No further questions were asked of him.

I advised him he was now being investigated for Hit and Run - Property damage and/or Hit and Run - Injury which was a felony. I advised him that numerous people he had hit had complained they were hurt but they hadn't submitted a written statement or been transported to the hospital so at this point I wasn't going to be arresting him until such a time as I knew which criminal statute he violated.

I gathered his driver's license, vehicle registration and proof of insurance for inclusion into the call. Once I had the information I needed from these documents they were returned to him and he was released.

I advised him I would be off for the next three days and told him he needed to decide if he wanted to tell the truth or continue to lie about the incident. I advised him once I had written victims statements I would be forwarding the appropriate charges based on the victims statements. CAVENESS didn't seem to care.

12/08/2015

Upon returning to work I found MOLLEKER's victim statement in my officer's mail box. I reviewed this statement and noted she wrote that she was injured and would be seeking medical treatment from her doctor.

I knew from passed experience victim statements usually took a few days to be written so I decided to wait to complete the case report until 12/10/15.

12/10/15

I received victims' statements from Sarah Crist, Laura Ramos and Heather Cromwell which all indicated various forms of minor injury from the collision caused by CAVENESS.

I have not received any contact from CAVENESS to accept his responsibility in the collision.

As such I believe there is probable cause to believe Taylor W CAVENESS caused a vehicle collision that injured multiple driver's and then intentionally fled the scene of that collision in violation of RCW 46.52.020(4b) Hit and Run - Injury (a felony)

As such I referred felony hit and run charges to the Prosecutor's Office for filing.

While I was enroute Dispatch advised the causing vehicle, later positively identified as WA license AUD8741 being driven by Taylor W Caveness 07/03/1996, had fled the scene. The vehicle was reported as fleeing at a high rate of speed east on Lundeen Parkway.

An uninvolved witness followed the suspect vehicle to Norm's Market and confronted the male driver (CAVENESS). CAVENESS fled again to Jay's Market while calling his girlfriend and refusing to call the police as she directed him to.

LSPD Sgt. Miner was able to talk CAVENESS into returning to Norm's Market.

The victims of the multiple vehicle hit and run needed a few days to write their statements.

After the collision scene was cleared I contacted CAVENESS at Norm's Market where he continued refused to accept responsibility for the crash and/or fleeing the scene. He was released.

I gathered the victims' statements and noted they all indicated minor injuries due to the collision. As such charges are being forwarded for Felony Hit and Run - Injury.





I was moving very slowly as I was preparing to stop in accordance with the traffic slowing to a stop ahead of me. I heard a huge BANG! crash behind me that was shockingly loud, then a slight delay as the vehicle behind me was pushed into my rear end. The impact was so forceful that the front of my body ^{the front of my body} bumped against the steering wheel as I slammed on my brakes, and my keys were actually knocked out of the ignition. Wind was knocked out of me and I felt completely shocked. I was pushed into the vehicle in front of me and after a slight delay, and that second impact was very forceful and I could feel shock from that, too. I did not see the vehicle who caused the pile-up. I glanced over my shoulder and saw the vehicle behind me having been pushed into right lane and pushed sideways. A good samaritan man approx. 30 years old came running to help, I believe he helped move the vehicle behind me to side of road. He asked me to see if I could drive my car to side of the road. to start my vehicle and drive it to the side of the road. I got out of my vehicle and the good samaritan asked if I was injured. I bumped into the steering wheel - my chest did. The impact from behind and the impact when I was pushed into vehicle in front of me knocked wind out of me and made me feel huge ^{physical} shock. Experiencing soreness in the sternum area, and possible soreness in knee area of right leg where I believe my leg banged into the car below steering wheel (this is leg I slammed on the breaks upon impact to try to control the car). Overall, feeling shock and shakiness and soreness ~~in~~ in body, mostly sternum and knee, but did not seek medical attention at the time. When I got out of the vehicle, I checked for damage to my vehicle. Damage to my vehicle is as follows, though damage may be more extensive once repair men investigate the totality of damage: (1) entire rear bumper dislocated and pushed out of place. (2) front ~~right~~ right headlight turn signal knocked out, and body of vehicle surrounding that area is damaged. (3) Front grill of vehicle slightly pushed in / front grill or bumper area affected / pushed out of place / bent. (4) battery within hood / engine of front of vehicle ~~is~~ dislocated upon outside impact.

Police officers and fire fighters / aid workers came to check my vehicle, ask if I needed to go to hospital, and police officer took my insurance, registration, and driver's license.

Entire accident was hugely impactful, very loud, shocking, stopped traffic, suddenly the entire area swarming with people and flashing lights and police and aid workers.

Feeling soreness and shocked, Wind knocked out of me. Unsure ~~if~~ as to the totality of soreness or internal injury / distress. Still feeling shock / adrenaline / shaky
