## NARRATIVE

Traffic unit #1 was traveling northbound on 91st Avenue NE and approached the signal controlled intersection with Market Place. Traffic unit #2 was properly stopped facing westbound on Market Place at the signal controlled intersection with 91st Avenue NE, within the left turn lane. Traffic unit #1 made a right turn eastbound onto Market Place when its truck canopy became unsecured from the bed of the vehicle. Traffic unit #1 canopy fell off of the vehicle and to the ground; sliding into traffic unit #2. After colliding with traffic unit #2 the truck canopy came to rest within the roadway of Market Place.

-Immediately following the collision, I arrived within the area and viewed the above vehicles stopped at the roadway edge of Market Place. SNOPAC dispatch was advised of the incident and location.

-Both traffic unit operators stated they were not injured during the incident.

-Traffic unit #1 operator stated the bolts securing his truck canopy must have broken off, causing the canopy to become unsecured and collide with traffic unit #2.

-The above mentioned truck canopy had been removed from the roadway and was sitting on an adjacent sidewalk at the time of my arrival.

-No bolts were discovered about the canopy, truck bed, or roadway.

-No bolt holes were located within traffic unit #1 bed rails or canopy rails (attachement points).

-Handheld spring clamps were discovered about both sides (bed rails) of traffic unit #1 bed upon my inspection.


-No commercial canopy clamps were discovered within the bed or canopy of traffic unit #1.

-Traffic unit #1 operator provided an expired (2013) Titan Insurance Company policy card. TU1 operator stated he had just renewed his policy with Titan Insurance Company and the valid cards were at his residence. I later contacted Titan Insurance Company (Customer Service Rep LOWET15) and found the policy had been canceled on June 21, 2013.

-Traffic unit #1 operator was unable to provide a valid operator license at the time of being contacted. TU1 operator provided his full name, birthdate, and residence address, which were found to match the above vehicle registration plate.


