

SUMMARY:

On 12/14/2015 at about 1727 hours driver Kari Cunningham DOB 1966 rear ended an occupied vehicle being driven by Gibson at the intersection of SR 204 and 91st Ave NE, in the city of Lake Stevens, and fled the scene. Cunningham had been in a left turn lane, then after the collision backed up and fled the scene, making a right turn over two lanes of traffic and speeding away. Cunningham's vehicle was found at her residence and Cunningham would not answer the door for police. Damage to Cunningham's vehicle was consistent with having been involved in the collision. Cunningham was identified by Gibson, by a DOL photo on New World, to be the driver of the vehicle that hit her and fled the scene. Cunningham was cited for hit and run occupied motor vehicle and no vehicle insurance (sent to the court for mailing).



On the date and time of this incident I had legal authority to arrest. I am a fully commissioned police officer, certified by the State of Washington to enforce the laws of Washington State and am currently commissioned by the Police Chief of the Lake Stevens Police Department. I have been a city of Lake Stevens Police Department Police Officer for over 15.5 years. On the date and time of this incident I was wearing a full Lake Stevens Police Department issued POLICE duty uniform which includes shoulder department patches and a chest badge which clearly identified me as a law enforcement officer. On the date and time of this incident I was operating a marked Lake Stevens Police Department patrol vehicle equipped with emergency overhead lights.

This incident occurred in the city of Lake Stevens, which is located in Snohomish County in the State of Washington.

SUMMARY:

On 12/14/2015 at about 1727 hours driver Kari Cunningham DOB 1966 rear ended an occupied vehicle being driven by Gibson at the intersection of SR 204 and 91st Ave NE, in the city of Lake Stevens, and fled the scene. Cunningham had been in a left turn lane, then after the collision backed up and fled the scene, making a right turn over two lanes of traffic and speeding away. Cunningham's vehicle was found at her residence and Cunningham would not answer the door for police. Damage to Cunningham's vehicle was consistent with having been involved in the collision. Cunningham was identified by Gibson, by a DOL photo on New World, to be the driver of the vehicle that hit her and fled the scene. Cunningham was cited for hit and run occupied motor vehicle and no vehicle insurance (sent to the court for mailing).

NARRATIVE:

On 12/14/2015 at about 1727 hours (all times approximate) I was dispatched by police radio to a priority hit and run vehicle collision at the intersection of SR 204 and 91st Ave NE in the city of Lake Stevens. The fleeing vehicle was described as being a Lexus SUV license plate ALS1395. The return information on the fleeing vehicle showed the registered owner to be Kari Cunningham at the address of 8916 Meridian Place NE #204 in Lake Stevens.

Officer Warbis went to check Cunningham's residence while I went to the scene of the collision.

Arriving on scene I met with victim driver Lisa Gibson and two witnesses (husband and wife Casey and Stuart Chaffee).

Gibson stated she was on westbound SR 204 in the left turn lane for southbound 91st Ave NE (stopped) when she was rear ended by a vehicle that came up behind her. Gibson got out of her vehicle to make contact with the driver who had hit her and the driver would not look at her (having her head down) or talk to her. Gibson returned to her vehicle to call 911 when the other driver backed up and fled the scene speeding northbound on 91st Ave NE. Gibson stated she was shocked that someone would leave the scene of a collision. Gibson described the female

driver as being an adult female with blond hair.

Witnesses Casey and Stuart stated they had been behind the car that rear ended Gibson's vehicle. Stuart stated they were in the left turn lane for southbound 91st Ave when the car in front of them rear ended the car in front of it. Stuart got the vehicle license plate (ALS1395). The vehicle that had ran into the back of the other vehicle sat there for almost a minute before reversing, changing two lanes to make a right turn and drove off.

Casey stated she was approaching the red light at the intersection where there were already two cars stopped and one car was traveling in front of her. Casey stated the vehicle traveling in front of her "plowed" right into the rear of the car that was stopped, waiting at the light. The driver of the car that hit the other car did not get out. Instead she waited about a minute, reversed her car, cut over two lanes of traffic, turned right and sped off. Casey stated the car that rear ended the other car did not slow down at all before driving right into the back of the stopped car, then she fled the scene.

I noted damage to the back of Gibson's van on the rear lower right side of her vehicle's bumper. Due to the design of the bumper and how it was explained the other car had hit the back of Gibson's vehicle, I believe there is more unseen damage behind the bumper covering to the vehicle's safety feature.

I obtained statements and took digital images of Gibson's vehicle.

Officer Warbis advised me Cunningham's vehicle was at her residence and she was not coming out. I responded to Officer Warbis' location in an attempt to contact Cunningham.

I had ran Cunningham over my mobile data computer and observed her Department of Licensing photo image (having blond hair). The return also indicated Cunningham had a prior DUI charge and an ignition interlock requirement in 2013 for one year.

I arrived with Officer Warbis and observed light damage to the front of Cunningham's vehicle (ALS1395); consistent with the damage I would expect to see in this collision as reported to me by Gibson and witnesses. Also inside the vehicle, on the passenger side, was a purse (upside down) on the floor board, along with papers which had Cunningham's name on them (resume).

Officer Warbis stated when he had first arrived, there had been a light on inside Cunningham's unit (hours of darkness) and now the light was off. I knocked on the front door and rang the doorbell several times. No one came to the front door. I positioned my patrol car spot light on a front window of the residence and activated the emergency lights on my patrol car. I again knocked on the front door and rang the doorbell. No one came to the front door. I remained in front of the residence for about 5 minutes with all my emergency lights activated and no one came out of Cunningham's residence. Several neighbors were looking outside at this time to see what was going on.

I took digital images of Cunningham's vehicle and of the front end damage.

I contacted Gibson again and asked her if she could look at a DOL photo to see if she recognized the person. I met with Gibson at her residence and showed her the DOL photo of Cunningham (which was on my mobile data computer in my patrol car). Gibson immediately stated the picture of Cunningham is the same woman who had hit her tonight and fled the scene.

At this time I shall complete a criminal citation, to be mailed by the court to Cunningham, for hit and run occupied vehicle and a traffic infraction, to be mailed by the court to Cunningham, for no vehicle insurance.
