NARRATIVE

11/11/15 1205 hours, I was dispatched to a two vehicle non-blocking/unknnon injury collision at the 7200 blk of 20th Street SE. Upon arrival I found a black Subaru Outback (vehicle 2) with rear end damage in the westbound lane. The vehicle was partially on the shoulder and partially in the lane of travel. There was a blue Toyota truck (vehicle 1) in front of vehicle 2 with front end damage. The driver of vehicle 2 said she was west bound on 20th Street SE and had slowed because she was looking for an address. The driver of vehicle 1 said he was west bound on 20th Street SE and must have taken his eyes off the road and collided with the slowing vehicle 2.
