



## CITY OF LAKE STEVENS VOLUNTEER OPPORTUNITIES

### **PLANNING COMMISSION**

The City of Lake Stevens is seeking community members living in the City limits or the Lake Stevens Urban Growth Boundary interested in serving on the Planning Commission. The Planning Commission is the principal planning advisory body to the City Council for matters relating to land use, the Growth Management Act, comprehensive planning and zoning issues. The current opening is to fill a vacant position for a term expiring on December 31, 2020. The Planning Commission holds regular evening meetings (7:00 p.m.) on the first Wednesday of the month. Occasionally a Planning Commission meeting is held on the third Wednesday of the month. ### **VETERANS COMMISSION**

The City is requesting applications from persons interested in filling a vacancy on the newly established Veterans Commission for a term expiring December 31, 2018. The Veterans Commission represents the U.S. military veteran constituency in the Lake Stevens community and works to provide support and opportunities to veterans and their families in the community. The Veterans Commission is comprised of eleven members, consisting of three Lake Stevens City Council members and eight members who are veterans, active military service members, or immediate family members, such as spouse, parent or adult child of a veteran or an active military service member, and are residents of Lake Stevens and/or the Lake Stevens Urban Growth Area or are property owners in Lake Stevens. ### **SALARY COMMISSION**

The City of Lake Stevens is seeking applicants for vacancies on the Salary Commission. The Salary Commission is established in [Lake Stevens Municipal Code, Title 2, Section 2.51](#) for the purpose of establishing the salaries of elected officials on realistic standards so that elected officials are paid in accordance with their duties and so that citizens of the highest quality are attracted to public service (LSMC 2.51.010). The Salary Commission meets annually between January 1 and November 1 to study and establish the salaries of elected officials. The specific duties are set forth in LSMC 2.51.050. Meetings are scheduled by the Secretary. Salary Commission members must be a U.S. citizen, and a resident of the City of Lake Stevens for at least one year preceding appointment. Salary Commissioners serve without compensation for three year terms
