A few highlights from the report showcasing the City's recent growth in 2021:

- Completion of Phase II of the North Cove Park/Downtown Lake Stevens Expansion.
- Breaking ground on the Costco Development, scheduled to open fall 2022.
- Through the completion of the Southeast Interlocal Annexation Area in August, just over 3000 people are now residents of Lake Stevens.
- The city received the 2020-21 Governor's Smart Projects Award for the Downtown Lake Stevens Subarea Plan.

We start 2022 excited about the additional growth coming to Lake Stevens. The City continues to work on improving work flow process from the use of cutting edge software to Public Works accreditation. With the planned creation of a new Parks and Recreation Department to long-awaited improvements reducing congestion and traffic flow, the City's goal is to continue attracting new businesses and opportunities so residents can work and play closer to home.

The City remains focused on the mission at hand, One Community Around the Lake. We thank each member of the Lake Stevens community for their continued engagement and support.

Lake Stevens Farmers' Market 2021

Under the direction of Market Manager, Sarah Dylan Jensen, the market's second year was an even bigger success and boost to the local economy than the inaugural market.

- Spanning 13 weeks for the summer market season, averaging 80 vendors per month.
- Total market revenue (all vendor sales combined): \$461,672; an increase of \$106,000 from 2020.
- The Harvestfest Market hosted 78 unique vendors.



We look forward to an even more successful 2022 summer market season.
