

**CITY OF LAKE STEVENS
CITY COUNCIL REGULAR MEETING MINUTES**

June 28, 2022, at 6:00 p.m.

Hybrid Meeting - By Remote Participation via Zoom & in Person at The Mill Building

CALL TO ORDER: 6:00 p.m. by Mayor Gailey

ELECTED OFFICIALS PRESENT: Mayor Brett Gailey, Councilmembers Kim Daughtry, Gary Petershagen, Mary Dickinson, Marcus Tageant, Anji Jorstad and Steve Ewing

Call to Order

The Mayor called the meeting to order at 6:00 p.m.

Pledge of Allegiance

The Mayor led the Pledge of Allegiance.

Roll Call

All Councilmembers were present except Councilmember Frederick.

MOTION. Councilmember Tageant made a motion, seconded by Councilmember Jorstad, to excuse Councilmember Frederick. The motion passed 6-0-0-1.

Approval of Agenda

Mayor Gailey requested that an executive session be added to the beginning of the agenda, before guest business, for a duration of 15 minutes with no action to follow.

MOTION. Councilmember Jorstad made a motion, seconded by Councilmember Tageant, to remove action item 11.A, "Moratorium on Short Term Rentals" from the agenda.

MOTION. Councilmember Petershagen called a Point of Order asking if there would be questions allowed regarding Councilmember Jorstad's motion. Councilmember Jorstad clarified that she was asking for the entire agenda item to be removed from the agenda with no discussion and no action on the item. A roll call vote on the amendment was requested.

MOTION VOTE: The motion passed 4-2-0-1 with Councilmember Daughtry and Councilmember Petershagen opposed.

Mayor Gailey pointed out that there was not a motion on the floor yet to add the executive session to the agenda.

MOTION. Councilmember Jorstad made a motion, seconded by Councilmember Ewing, that the agenda be amended to include an executive session before guest business. The motion passed 6-0-0-1.

Executive Session

The meeting recessed to executive session at 6:20 p.m. to discuss potential litigation for approximately 15 minutes with no action to follow.

Reconvene to Regular Session

The meeting reconvened to regular session at 6:35 p.m., members of the public were brought back into the Council Chambers.
