Call to Order

MOTION. Councilmember Daughtry made a motion, seconded by Councilmember Donoghue, to approve the agenda with the removal of 7c (Authorization/Resolution for Application with Recreation Conservation Office). The motion passed 5-0-0-2.

Council Business

Councilmember Jorstad reported that she met with Fire Chief O'Brien and will update the Council at the next meeting.

Councilmember Daughtry reported on the Aquafest event over the summer. He also reported on Community Transit and Puget Sound Regional Council.

Councilmember Petershagen addressed some recent social media posts. The posts are accusing the City of wasting \$400,000 in fines related to ADA violations. He stated that the Council does have respect for the public's money and the posts are not accurate. Public Works Director Halverson and Finance Director Stevens both reported that the City has had no penalties/fees.
