Planner Needman explained that following a public hearing, staff is requesting the Council approve Resolution 2025-11 which would accept the 60 percent Fagerlie West annexation petition and provide notice of intent to annex to the Snohomish County Boundary Review Board (BRB); and require the simultaneous adoption of the existing land use and zoning predesignations and assumption of all existing City indebtedness upon annexation.

Ryan Larsen, Land Pro, Applicant. Ryan spoke in favor of the annexation.


Council President Donoghue closed the public hearing.
