Call to Order

2026 Annual Budget — Public Hearing No. 2 - Ordinance 1205

Finance Director Stevens presented Ordinance 1205 to the Council and stated that no changes had been made to the 2026 annual proposed budget since the first public hearing on November 18, 2025. Discussion occurred.




Further discussion on the budget will come back at the next meeting.
