ALL ELECTRONIC SUBMITTALS NEED TO BE RECEIVED BY THE CITY AT THE TIME OF APPLICATION. PLEASE NOTE ALL APPLICATION MATERIALS MUST BE SIGNED. IF THE REQUIRED MATERIALS ARE NOT PROVIDED, THE CITY CANNOT ACCEPT THE APPLICATION.**

Letter of Water Availability from **Snohomish County Public Utility District (PUD)**

Intake Fees (See current Fee Schedule)

\$150.00 Model Home Review Fee

Administrative Review for Model Homes include a flat fee of \$150 for the first two hours of review and an addition \$100.00 per hour for each additional hour of review. Any additional hours billed must be paid prior to building permit issuance.
