



## Permit and Service Fees

**EFFECTIVE JANUARY 1, 2025**

### **BUILDING PERMITS, COMMERCIAL/MULTI-FAMILY PLUMBING AND MECHANICAL PERMITS**

International Code Council Valuation Data Table applies to all Building and Single-Family Permits construction valuation or the International Building Code for square footage, whichever is greater unless otherwise noted. Commercial/Multi-Family Plumbing and Mechanical Permits are valuation-based on the International Code Council Valuation Data Table, unless otherwise noted. Fees listed are in addition to Plan Review and/or Inspection fees. Fees for permits include permit process, file management, payment processing, coordination and inspection which are comprehensive, with two (2) correction each; all additional inspections, and submittals shall be charged at the hourly rate after two.

#### **MECHANICAL AND PLUMBING FEES**

Fees for inspections are comprehensive, with two (2) corrections each; all additional plan reviews shall be charged at the hourly rate.

**TECHNOLOGY FEE**

In addition to any other fee or charge required by the City, every person paying any fee or charge shall pay a technology fee to the City (Resolution 2024-13)

- 5% of fees or charges

**SERVICE FEE**

A non-refundable service fee of three percent (3%) shall apply to all payments made to the City except for payments made by cash/check, boat launch fees, Police Department fees and charges related to duplication of public records (Resolution 2025-09)

The City will use an annual five-year average CPI-U adjustment to the land use, building permit and park and traffic impact fees to update fees annually. This CPI-U adjustment will occur and become effective January 1st of each successive year.
